### **ELIGIBILITY REQUIREMENTS**

Interested competent and reliable contractors are required to provide verifiable evidence including but not limited to the following documents:

- i. Certificate of incorporation with Cooperate Affairs Commission;
  - ii. Certified true copy of Memorandum and Article of Association;
  - iii. Evidence of registration with Jigawa State Works' Registration Unit;
  - iv. Tax Clearance Certificate for the last three (3) years;
  - v. Audited account for the last one (1) year;
  - vi. VAT registration and evidence of past remittance;
  - vii. Evidence of financial capability and banking support;
  - viii. Company average annual turnover of not less than ₦20M
  - ix. Evidence of similar project executed (letter of award and completion certificate) at least three (3) in the last five (5) years;
  - x. That the company has fulfilled all obligations to pay taxes, pensions and social security contributions;
  - xii. A sworn affidavit certifying as follows:
    - a. That the documents submitted for the bidding exercise are not genuine but correct
    - b. That none of the Directors of the company has been convicted by any Court of law
    - c. That the company is not bankrupt
    - d. That none of the officer of Jigawa State/Local Government is a present or former Director of the Company
  - xiii. Any other relevant information that will help in determining the company's suitability for the work;
- Any prospective bidder that does not possess any of the above documents need not apply.

## **COLLECTION OF TENDER DOCUMENT**

Interested bidders are to collect the Tender documents from the **(Procurement Office)** Office of the Permanent Secretary, Ministry for Local Government and Community Development Dutse, from the date of publication of this advert and between the hours of 09:00 am and 05:00pm daily after a payment of a non-refundable fee of ₦10,000.00 (Ten Thousand Naira Only)

## **SUBMISSION OF TENDER DOCUMENT**

Technical and financial bids shall be submitted in two different sealed envelopes and labeled "Technical bid" and "Financial bid" respectively with the company's name indicated at the back of each envelope. Both envelopes should be placed in a sealed third envelope addressed and delivered to the **(Procurement Office)** office of the Permanent Secretary, Ministry for Local Government and Community Development not later than 5<sup>th</sup> July, 2022 by 12: 00 Noon.

All documents for submission must be transmitted with a forwarding letter dully signed by company representative under the company's Letter Headed Paper bearing the CAC Registration Number (RC), Contact Address, Telephone Number (preferably GSM No) and e-mail address.

The financial bid should contain a bid security of not less than 2% of the quoted bid.

The bid validity period should be 120 days from the deadline of the bid submission date.

## **OPENING OF BIDS**

Only technical bids shall be opened immediately after the deadline for submission at 12:00 Noon.

## **GENERAL INFORMATION**

- i. Bids submitted after the deadline for submission will be returned un-opened;
- ii. Only the financial bids of successful bidders will be opened, while those for the un-successful bidders will be returned un-opened;
- iii. This advert shall not be construed as commitment on the part of the Jigawa State Ministry for Local Government and Community Development nor shall it entail a company to make any claim(s) whatsoever and/or to seek any indemnity from the Jigawa State Ministry for Local Government and Community Development by virtue of such company having responded to this advertisement;

- iv. All costs will be borne by the bidders as the Jigawa State Ministry for Local Government and Community Development will not be held responsible for any cost or expenses incurred by any interested party (i.e) in connection with any response to this invitation;
