INVITATION FOR SUPPLIERS PRE-QUALIFICATION

INTRODUCTION

The Jigawa Medicare supply organization (JIMSO) wishes to invite suitable and reputable companies to apply for pre-qualification for the supply of Drugs and other medical consumables (DRF ITEMS) to boost and support the State vibrant **Sustainable Drug Supply Systems (SDSS)** through the platform of **Drug Revolving Fund (DRF)** scheme.

SCOPE OF WORK

The pre-qualified suppliers will be

1. The main source of supplies for State SDSS.
2. Used as source of price survey for the DRF scheme.

After the pre-qualification activity, there will be a restricted invitation for tender to cover the SDSS needs of Jigawa state.

PRE-QUALIFICATION REQUIREMENTS

Participation in the pre-qualification is opened to all suppliers with legal and technical ability to manufacture and/or supply drugs & medical consumables in the health sector within Nigeria.

Interested suppliers are to submit comprehensive document containing the following:

- i. Certificate of incorporation/business name registration.
- ii. Certified true copy of memorandum and article of association.
- iii. Company organogram, technical qualification and experience of key personnel.
- iv. Premises license as a manufacturer and/ or distributor or wholesaler of pharmaceuticals and/or other medical supplies from the Pharmacists Council of Nigeria or any other relevant authority.
- v. Company audited account for the last one year.
- vi. Evidence of financial capability and banking support.
- vii. Verifiable evidence of executing or participating in similar supplies/contracts within the last three years.
- viii. A valid annual practicing license of superintendent pharmacist
- ix. Tax clearance certificate for the last three years.
- x. Copies of valid certificates for products registration with NAFDAC.
- xi. Letter of Authority from parent company of products marketed by distributors/ wholesalers
- xii. Registration with Jigawa State Due Process & Project Monitoring Bureau.
- xiii. Evidence of VAT registration
- xiv. Evidence of compliance with section 6 (i)-(iii) of the Industrial Training Fund (ITF) Amended Act No.19 of 2011 for the last one year.

In addition, interested suppliers shall be free from the following situations:

1. Bankruptcy
2. Committing an offence or crime of professional misconduct
3. Breach of any contract
4. Being liable for mis-representation of information in a previous tender

All documents should be submitted to the General Manager, JIMSO, Birnin-kudu, Jigawa State between 9:00 am and 4:00 pm from Monday to Friday, within two (2) weeks of this publication.
