TENDER REQUIREMENT

- e. Tax clearance for the last three years
- f. Evidence of financial capability and banking support
- g. Technical qualification and experience of key personnel
- n. Evidence of similar project executed over the last three years
- i. List of equipment and technical capacity
- j. VAT registration of past remittance

COLLECTION OF TENDER
